# A Brief History

- 1926: Founded by Dr. Robert Kehoe to study the toxicity of Freon and lead, which was funded by General Motors (GM)
- 1930: Named Kettering Laboratory of Applied Physiology after GM President Charles Kettering
- 1949: Joined with UC Department of Preventive Medicine to form the Department of Preventive Medicine and Industrial Health in the UC College of Medicine
- 1965: Re-named Department of Environmental Health (coinciding with founding of National Institute of Environmental Health Sciences within NIH)
- 2015: 50<sup>th</sup> Anniversary celebration of the naming of the Department and NIEHS
- 2019: Re-named Department of Environmental and Public Health Sciences to reflect the department's increasing focus on public health

## **Completing Your Degree - Policies**

- Minimum GPA: 3.0
- Time to Complete Degree
  - MS/MPH: 5 years maximum
  - PhD: 9 years maximum
- Part-time vs. Full-time
  - <u>Part-time</u>: 9 credits or less
  - <u>Full-time</u>: 10-18 credits
  - Funded: 12 credit minimum (or you lose funding)
- Active Graduate Student Status
  - Must register for at least 1 credit hour per academic year
- PhD Residency Requirement
  - PhD students <u>MUST</u> be full-time for at least one academic year (10 credit minimum per semester)
  - Must be completed in two semesters during the same AY
  - Note: a PhD cannot be completed only attending part-time

Provides general consultation, guidance and program advisement to MPH students	Advises on career related course-decisions
Connects students to MPH resources	Facilitates and/or approves practicum/capstone experiences
Processes, verifies, and/or approves MPH course registration and permits	Reviews/approves advanced standing, subplan change, and outside electives
Assists in preparation of student's class schedule and answers questions pertaining to course availability	
Monitors MPH student progress to degree and conducts degree audits	
Facilitates and/or approves course exceptions, waivers, and substitutes	
Answers questions pertaining to MPH program requirements, policies and procedures	
Communicates with students about academic deadlines and relevant information	
Tracks and receives documentation of volunteer hours and seminar attendance	
Provides assistance with thesis committee procedures when needed
